Steamboat Springs is known as Ski Town USA and is a first-class destination resort. It has produced more winter Olympians than any other town in North America. There is no other place like it on earth. Steamboat Springs is located 7000 ft. up in the Colorado Rockies at the foot of Mt. Werner; a ranching town that never strays very far from its roots. In Steamboat, the Old West is alive and well! Steamboat boast a huge variety of terrain and plenty of off-slope activities.

The mountain offers great tree skiing, wide open meadows, long bump runs, and groomed cruisers so skiers of all ability levels have plenty of options. Almost 3,000 skiable acres await you, spread across 5 mountain peaks with 3,700 ft. vertical. The trails are rated 13% beginner, 56% intermediate and 31% advanced.

After a day on the slopes, explore the genuine western town of Steamboat Springs and its many old-time saloons and shops. You can also relax in the nearby hot springs (see below). Your home will be the Ranch Condominiums, the club's favorite lodge in Steamboat. The ranch has a private shuttle to/from the ski mountain and an on-call private shuttle to take you anywhere in the area, plus an outdoor pool, one indoor & two outdoor hot tubs to soothe your body after a day of bashing the bumps! Each 3 bedroom, 3 bath condominium is equipped with a full kitchen, private balcony, electric BBQ and wood-burning fireplace.

STEAMBOAT TRIP APPLICATION & POLICIES/TERMS/CONDITIONS

A. TRIP PAYMENT SCHEDULE:

1. \$390 deposit due with application (\$405 for non-members). \$385 due Oct. 31, 2008; \$385 due Dec. 19, 2008
2. Automatic cancellation if payments are not received on time and there is a waiting list. Cancellation policy still applies.

B. GENERAL:

1. Prices are subject to change in transportation, lodging and lift ticket rates (and currency exchange -- where applicable).
2. Sign-up for all trips will start 23 Aug. 2008, and will require deposit in strict accordance with trip payment schedule.
3. All persons going on trips who are not members of the BOEING EMPLOYEES' SKI CLUB will be charged an additional \$15.00 non-member fee. This includes (a) Boeing employees who are not members of the club; and (b) non-Boeing employees or guests. Non-member fees are due with deposit. **This is a one-time fee per season, regardless of the number of trips attended that season. If signing up for more than one trip, inform the trip captain if you have paid the fee on another trip.**

EXAMPLE: Ski Missouri - member cost \$225, non-member/guest cost \$240

4. For membership information, contact Jim Mills 233-4742.
5. Boeing Corporate Policy limits non-member trip participation. Applicant acknowledges that they may be bumped from the trip if the required ratio of members to non-members is not met. Contact the Trip Captain for explanation of the BESC-STL bumping policy. See (C-4) for cancellation/refund information regarding the bumping policy.

C. CANCELLATION/TRANSFER FEES:

1. For each cancellation or transfer, minimum charge is \$15.00.
2. Transfer means to cancel from one Boeing Employees' Ski Club trip for the purpose of booking another Boeing Employees' Ski Club trip within the same season.
3. The trip captain will determine the charge for outright cancellations. Fees will be based on actual costs incurred, plus the \$15 service charge.
4. If the cancellation is caused by implementation of the BESC-STL bumping policy set forth in (B-5), all deposits will be refunded, and the \$15 cancellation fee will be waived.

D. CANCELLATION/REFUND POLICY:

1. To cancel a trip, the requester must make a written request. No refund will be made without a signed and dated written request.
2. Applicable cancellation fees listed in (C-3) will be levied if costs are incurred to execute the cancellation.
3. If no costs are incurred, the minimum charge (C-1) will be deducted from the refund.
4. If a suitable replacement is found, all money less minimum charge and actual cancellation costs specified in (C-3) will be refunded.
5. If a suitable replacement is found, the appropriate amount of refund will be made within four weeks after receipt of the replacement's appropriate payment(s).
6. If no suitable replacement is found, the appropriate amount of refund, if any, will be made within four weeks after the trip returns and the written request is on file.
7. If the cancellation comes from a triple occupancy unit, and no suitable replacement is found, the person canceling will be responsible for the differential between the double & triple occupancy rate. This amount will be deducted from any refund.
8. The trip captain will provide a detailed explanation of costs incurred by cancellation to the requestor as part of the account settlement.
9. Any deviation from above will require action from the Club Refund Committee, consisting of the President, Executive Vice-President and Vice-President of Trips. Resolution of the deviation will be handled on a case-by-case basis. The \$15 minimum fee is irrevocable, except cancellations caused by conditions set forth in (B-5).
10. The Boeing Employees' Ski Club - St. Louis reserves the right to cancel the trip in its entirety if the number of attendees does not meet the minimum required to ensure financial viability. All attendee payments will be refunded if this action is taken.

E. OCCUPANCY:

1. Trip is priced based on double occupancy

F. SMOKING POLICY:

1. All unit assignments will be non-smoking regardless of lodging designation (ex. if the property manager lists the unit as "smoking"). The only exception to this policy will be if ALL roommates/condo mates agree to permit smoking in the unit.
