After a 16 year hiatus, the club makes a rare visit to Montana. Big Sky offers instant access to some of the most diverse skiing and snowboarding amongst breathtaking vistas. Float down a 2,000 vertical foot, powder filled bowl beneath Lone Peak; bob and weave through the Bavarian Forest; ride the Lone Peak Tram for a bird's eye view of untamed wilderness. You'll find almost twice as many acres as skiers - lots of elbow room. Big Sky contains 150 trails (14% beg., 26% int., 40% adv., 20% exp.) spread over 3,812 acres. There are 16 lifts to service the 4,350 ft. of vertical. The average snowfall is 400+ inches and the longest run is 6 miles. For an additional charge, you can also ski Moonlight Basin, which gives you access to an additional 80 trails on 1,900 skiable acres. We will be staying at Big Horn Condominiums. The units include a washer/dryer, full kitchen, and fireplace. Spend your day off touring Yellowstone National Park via snowmobile – it's like having the park to yourself!!!

B. GENERAL:

C. CANCELLATION/TRANSFER FEES:

1. For each cancellation or transfer, minimum charge is \$20.00.
2. Transfer means to cancel from one Boeing Employees' Ski Club – St. Louis trip for the purpose of booking another Boeing Employees' Ski Club – St. Louis trip within the same season.
3. The trip captain will determine the charge for outright cancellations. Fees will be based on actual costs incurred, plus the \$20 service charge.

D. CANCELLATION/REFUND POLICY:

1. To cancel a trip, the requester must make a **written request**. No refund will be made without a signed and dated written request.
2. Applicable cancellation fees listed in (C-3) will be levied if costs are incurred to execute the cancellation.
3. If no costs are incurred, the minimum charge (C-1) will be deducted from the refund.
4. If a suitable replacement is found, all money less minimum charge and actual cancellation costs specified in (C-3) will be refunded.
5. If a suitable replacement is found, the appropriate amount of refund will be made within four weeks after receipt of the replacement's appropriate payment(s).
6. If no suitable replacement is found, the appropriate amount of refund, if any, will be made within four weeks after the trip returns with a written request on file.
7. If the cancellation comes from a triple occupancy unit, and no suitable replacement is found, the person canceling will be responsible for the differential between the double & triple occupancy rate. This amount will be deducted from any refund.
8. The trip captain will provide a detailed explanation of costs incurred by cancellation to the requestor as part of the account settlement.
9. Any deviation from above will require action from the Club Refund Committee, consisting of the President, Executive Vice-President and Vice-President of Trips. Resolution of a deviation will be handled on a case-by-case basis. The \$20 minimum fee is irrevocable.
10. The Boeing Employees' Ski Club – St. Louis reserves the right to cancel the trip in its entirety if the number of attendees does not meet the minimum required to ensure financial viability. All attendee payments will be refunded if this action is taken.
