Join the club for our 6th European trip...back to the country where we started 20 years ago; Austria! Sölden is located 1 hour southwest of Innsbruck, in the Ötztal Valley near the Italian border. Sölden is the only European resort with 3 peaks over 3,000 meters, spread across 1,100 acres with 31 lifts to access the whopping 6,500 ft. of vertical (49% beginner / 32% intermediate / 19% advanced). Sölden's 2 glaciers provide snow sure conditions. Nearby Obergurgl-Hochgurgl has 24 lifts to service 4,200 ft. of vertical (32%/50%/18%). All resorts are connected by ski bus. We will be staying at the Hotel Tyrol, close to the Giggijoch Tal gondola. The package includes breakfast & dinner daily at the Tyrol. Sölden has a vibrant nightlife (called the "Ibiza of the Alps"). An optional non-skier tour package is available at an additional cost (minimums apply). The trip concludes with 2 days/nights in Munich (breakfast included).

5. If a suitable replacement is found, the appropriate amount of refund will be made within four weeks after receipt of the replacement's appropriate payment(s).
6. If no suitable replacement is found, the appropriate amount of refund, if any, will be made within four weeks after the trip returns with a written request on file.
