We will be visiting 3 of Tahoe's finest ski areas. Alpine Meadows has 100 trails (25%-40%-35%), with 2,400 acres & 1,800 vertical ft., with 13 lifts. Northstar consists of 70 trails (25%-50%-25%), with 2,240 acres & 2,241 vertical ft, served by 15 lifts. Finally, Mt. Rose has 43 trails (30%-30%-40%) with 1,441 vertical ft of skiing. At no extra charge, you get fantastic views of Lake Tahoe!

A private coach will take us to the mountains each day. We are staying in downtown Reno at the Silver Legacy Hotel. Located in downtown Reno, it's close to all the action in the "Biggest Little City in the World".

2. Applicable cancellation fees listed in (C-3) will be levied if costs are incurred to execute the cancellation.
3. If no costs are incurred, the minimum charge (C-1) will be deducted from the refund.
4. If a suitable replacement is found, all money less minimum charge and actual cancellation costs specified in (C-3) will be refunded.
5. If a suitable replacement is found, the appropriate amount of refund will be made within four weeks after receipt of the replacement's appropriate payment(s).
6. If no suitable replacement is found, the appropriate amount of refund, if any, will be made within four weeks after the trip returns with a written request on file.
7. If the cancellation comes from a triple occupancy unit, and no suitable replacement is found, the person canceling will be responsible for the differential between the double & triple occupancy rate. This amount will be deducted from any refund.
8. The trip captain will provide a detailed explanation of costs incurred by cancellation to the requestor as part of the account settlement.
9. Any deviation from above will require action from the Club Refund Committee, consisting of the President, Executive Vice-President and Vice-President of Trips. Resolution of a deviation will be handled on a case-by-case basis. The \$20 minimum fee is irrevocable.
